1. PREAMBLE :

The Author Settlor of the Trust are also hereinafter referred as the FOUNDER of the Trust ( which whenever the contexts so requires or admit means and include their legal heirs, representatives and assigns ).

2. CORPUS

Whereas Founder is desirous of creating a Public Welfare and Charitable Trust with an initial contribution of Rs. 100,000.00 ( Rupess One Lakh Only ) towards the Corpus of the Trust which is declared as the Trust Property with a view to promote Educational, Medical, Social and Charitable Objectives.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

The Founder herein creates a Trust by name " SHAIL FOUNDATION " with the objective hereinafter stated to be managed and administered by an autonomous Board of Trustees.

### 3. PRINCIPAL PLACE

The Principal Place of the Trust shall be at HOUSE No. 8, VILLAGE – JAMUHAR, 821305, DIST. – ROHTAS ( Bihar ) . However the Trust may change the Principal Place of Office from time to time if required.

### 4. AREA OF PERTATION

The Trust will carry out its charitable activities all over India.

### 5. TRUST PROPERTY & RESOURCES OF THE TRUST

(i) Hold the above said Trust-Fund and all other Funds, monies and property which may be received either by way of donations, subscriptions, gifts, income, rent, interest, dividend or otherwise, howsoever and investment representing the Trust Fund on Trust subject to the powers, provisions, agreement and declaration hereinafter declared and contained concerning the same.


(ii) Acquire by purchase/lease/mortgage/gift/grant/legacy/bequest/exchange, properties, rights, privileges or otherwise from any person, company, society, Government, Institution, Organisation or Body whatsoever movable or immovable properties of all description deemed necessary or useful for the purpose of the Trust and to collect funds by public or private appeal for carrying out the objects of the Trust and to construct buildings and to effect thereon improvements and maintain them and so also to dispose, sale, lease, gift, mortgage, alienate, transfer such property or properties in pursuance of objectives of the Trust.


(iii) For the purpose of carrying out the objects of the Trust and for providing the facilities and for undertaking activities as mentioned above, the Trustees shall be entitled to utilize the funds of the Trust as well as its income in such manner as they think proper.

(iv) To open bank accounts and operate the said accounts by the Founder or any other Trustee duly authorized by the Board of Trustees.

(v) To make rules, procedures and bye-laws for the conduct of the day to day affairs of Trust, for operation of its Institutions and to deal with its properties.

(vi) Receive contributions from within Indian and from abroad.

(vii) All funds, properties, rights, claims, demand of every description belonging or pertaining to the Trust now or as may hereafter be acquired from time to time shall vest in the hands of the Trustees.

(viii) Invest the funds of the Trust not immediately required in deposit with nationalized Banks or with undertakings or in any securities authorized under the Income Tax Act, 1961 or other applicable laws in force from time to time.

**6. OBJECTIVES OF THE TRUST**

**A. EDUCATION**

(i) Establish, maintain and run schools, colleges, social service centres, Industrial training centre and allied education institutions.

(ii) Establish, promote, support, maintain and manage aashrams for old aged parents, goshalas, schools, colleges, universities, hostels, libraries, study circles, reading rooms, lecture halls, museums and other establishments and institutions for the study, education and research on current education system as well ancient Indian values and culture, Indian ancient and contemporary languages, Yoga and Vedanta without any profit motive. world peace and maintenance of the nature and the environment and to see the oneness in all creatures.

(iii) Grant scholarships, stipends, free studentships, prizes, rewards and allowances, financial and/or other assistance to students, lecturers, teachers, scholars etc.

**B. MEDICAL RELIEF**

(i) Establish, maintain, run, develop, improve, extend, grant, donate for and to aid for running innovating health programmes including medical education in the area of Allopathy, Ayurveda, Homeopathy, Naturopathy and Yoga for the welfare of society at large.

(ii) To hold national and international conferences, seminars, camps etc. and publish research journals, literature and document the achievement of the health programme for the advancement and diffusion of knowledge in the field of Yoga, Ayurveda, Allopathy, Homeopathy, Naturopathy and so on.

(iii) To establish, promote, support, manage, help and run camps and seminars against drug abuse, dispensaries, hospitals, nursing homes, child welfare centers, medical centers, sanatoriums, clinics, laboratories, mobile medical units, medical units, research institutions, blood banks, camps and other establishment for giving medical relief to the public at large.

**C. RELIEF TO THE POOR**

(i) Provide medicines, goods, clothing, water, low cost housing and/or shelter for the poor or needy persons and to give help to them in cash or in kind.

(ii) To grant relief to the people affected by earthquake, flood, famine, fire, pestilence and other natural calamities of similar nature and to give donations, subscriptions or contributions to indigenous institutions or persons doing such relief work.

(iii) To establish, promote, support, manage, help and run orphanages and/or other establishment for relief of the poor and destitute, orphans, widows, Dharamshalas and Goshalas

**D. OTHER OBJECTIVES OF GENERAL PUBLIC UTILITY**

(i) To hold seminars, lectures, conferences as well as to make and publish books, scriptures, films, videos and any of learning material which serves the aims & objects of the Trust.

(ii) To organize training and opportunities for employment for women and youth.

(iii) To create awareness and responsibility towards the environment and related problems.

(iv) To establish meditation halls, public roads, parks, gardens, wells, tube wells, tanks and jalkshetras and/or grant and aid for the construction, maintenance and/or repair of the same for the public at large.

(v) To give assistance and/or grant in aid to trusts, institutions, funds individuals and/or other organizations engaged in the furtherance of similar aims, objects and activities.

(vi) Build up a network of concerned individuals and organizations for the furtherance the ideas and objectives of the Trust to create a feeling of solidarity among those working for the oppressed.

(vii) Generally to do all such other things as are incidental or conducive to the above objects and carry on any of the above activities in cooperation or association with any other person, organization, society or authority and to provide grants and other facilities to any other organization engaged in similar activities.

(viii) To do any other act for the advancement and welfare of general public not involving the carrying on of any activity for profit.

The Trust shall be an irrevocable public charitable trust for the benefit of all persons belonging to whatever community irrespective of caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment subscription, endowment, donation, contribution, or in any manner whatsoever ( all of which shall be designed as trust properties) on the Trust herein mentioned.

**7. BOARD OF TRUSTEES:**

The Board of Trustees shall comprise of a maximum of eleven Trustees and a minimum of three Trustees. The Founders of the Trust shall be trustees for Life and Smt. Shail Singh will be the Managing Trustees of the Trust for the time being these presents. The term of any new Trustee so appointed shall be a period of three years only. The vacancies on the Board of Trustees shall be filled by the Managing Trustee in his discretion for such term as stipulated at the time of their appointment. After the Managing Trustee ceases to be a Trustee by retirement or otherwise, the vacancies on the Board of Trustees shall be filled in by majority of the Board of Trustees for such period as may be stipulated at the time of appointment. The Office of the Managing Trustee shall be honorary. However the Trustees are entitled to the remuneration, if work for the Trust whole time and reimbursement from the Trust Fund for all expenses incurred by them for the purpose of the managing the affairs of the Trust. The Board of Trustees may invite Persons of eminence as a patrons of the Trust.

**8. POWERS OF THE BOARD OF TRUSTEES**

(i) That Board shall have the power and authority to administer the trust, its institutions, properties, funds etc. and to do all acts, deeds and things required to promote and pursue the objects of the Trust. They shall be entitled to act even if their number is reduced below three due to any delay in filling up the vacancy.

(ii) The Board shall have the power to open bank accounts and operate them, enter into contracts, agreements or understanding vary or rescind them, appoint, terminate or dismiss staff or employee etc.

(iii) Institute, prosecute and defend all such suits, legal and other proceedings on behalf of the Trust.

(iv) Prescribe from time to time the eligibility for the benefits provided by the Trust and to vary the conditions for the same from time to time. (v) Decide from time to time the works and programme of the Trust

### 9. MEETINGS OF THE BOARD OF TRUSTEES

(i) The Trustees may meet as often as necessary for the conduct of meeting of the Trust.

(ii) The quorum for the meeting shall two third of the Trustees present.

(iii) The Managing Trustee shall maintain a record of proceedings in the minute book of the meeting so held.

### 10. MANAGING TRUSTEE

The Managing Trustee shall have all the powers of managing the affairs of the Trust and its properties, sign documents, statements, affidavits, Declaration, return etc., appoint, transfer and terminate the employee, open and open bank accounts and attend to the day to day management of the affairs of the Trust. He/She shall do any act, deed or things necessary for carrying out the objects of the Trust subject to the directions of the Board of Trustees. By a Board resolution, any other person may be authorized to do the same.

### 11. FRAMING OF RULES AND BYE LAWS

The Board of Trustees may frame Rules and Bye Laws for the management of the Trust, its properties, institutions, staff and amend or rescind them as they deem fit.

### 12. ACCOUNTS AND AUDIT

The Trustees shall maintain the books of accounts regularly and close the books every years on 31<sup>st</sup> March. The Books of Accounts shall be audited by a Firm of Chartered Accountant or Chartered Accountant. The Trustees shall dully maintain true and correct accounts of all assets, disposals, receipts and expenses of the Trust and its institutions and present the audited accounts in the Annual General Meeting before the Board of Trustees and deliberation.

**13. LEGAL PROCEEDINGS**

The Managing Trustee has authority solely to institute all actions and proceedings in the name and on behalf of the Trust and the Trustees and also to defend them in respect of all matters concerning the Trust and its institutions, funds and properties. It shall not be necessary to join the other trustee in such actions or proceedings.

**14. INDEMNITY**

The Trustees shall be kept in indemnified and harmless by the Trust against any action, claim, demand or liability arising against them for anything done by them in good faith, pursuant to the power or authority vested in them under THESE PRESENTS.

**15. AMEDEMMENTS IN THE TRUST DEED**

The Board of Trustees shall have the power by three fourth majorities to make amendments in the Trust Deed as may be required for the smooth functioning of the Trust from time to time. However, no amendments to the Trust Deed shall be made which may prove repugnant to the provisions of Section 2(15), 11, 12, 13 and 80 G of the Income Tax Act, 1961, as amended from time to time. Further no amendments shall be carried out without the prior approval of the Commissioner of Income Tax.

**16. UTILISATION OF INCOME**

The Funds and income of the Trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the Trustees by way of profit, interest and dividend what so ever.

**17. BENEFITS OF THE TRUST**

The benefits of the Trust shall be open to all irrespective of caste, creed or religion.

**18. DISSOLUTION**

The Trust hereby created is irrevocable. However, if for any reason this Trust fails or it is resolved to dissolve this Trust at any future time, the Trustees shall transfer the Assets and Liabilities, Properties, Institutions and Funds to any other Public Charitable Trust or Society whose objects are similar to

those of this Trust and which enjoys recognition U/S 12 A & 80 G of the Income Tax Act, 1961 as amended from time to time. The Assets remaining as on the date of dissolution, shall under no circumstances be distributed among the Trustees.

**19. INTERPRETATION**

The Trust Deed and the rules and regulation of the Trust shall be interpreted by the Board of Trustees and their decision shall be final and binding.
